The bidding documents can be obtained from the BAC Secretariat after payment of non-refundable amount of five thousand pesos (₱5,000.00) at the PNRI Cash Section, FAD.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Philippine Nuclear Research Institute, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

Prospective bidders should be a Philippine Contractor Accreditation Board (PCAB) registered for government projects with License Category of at least D and Size Range of at least Small B for Well Drilling Work, if Contractor or those with experience in Borehole Drilling used in Water, Groundwater and Rock and Soil Analyses and Studies. Moreover, prospective bidders/contractors whose offices are not based in Metro Manila should have completed projects similar to the project for bidding within Metro Manila to enable the Procuring Entity to verify the quality of workmanship during post qualification evaluation.

For this purpose, similar projects shall refer to Well or Borehole Drilling Works.
