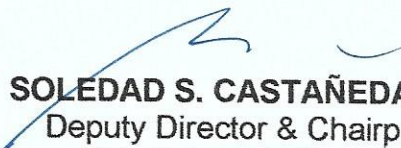
The eligibility Check/Screening as well the Preliminary Examination of Bids shall use the non-discretionary "pass/fail" criteria.
