They should be a Philippine Contractor Accreditation Board (PCAB) registered contractor for government projects with License Category C or D and Size Range of at least Small B for Building and Industrial Plant. Moreover, prospective bidders/contractors whose offices are not based in Metro Manila should have completed projects similar to the project for bidding within Metro Manila to enable the Procuring Entity to verify the quality of workmanship during post qualification evaluation.

For this purpose, similar projects shall refer to General Building.

The eligibility Check/Screening as well the Preliminary Examination of Bids shall use the non-discretionary "pass/fail" criteria.

All particulars relative to the Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post Qualification and Award of Contract shall be governed by the pertinent provisions of the 2016 Revised Implementing Rules and Regulations (IRR) of R.A. 9184.
