It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Philippine Nuclear Research Institute, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

The eligibility Check/Screening as well the Preliminary Examination of Bids shall use the non-discretionary “pass/fail” criteria.
