The bidding documents can be obtained from the BAC Secretariat after payment of non-refundable amount of five thousand pesos (₱5,000.00) at the PNRI Cash Section, FAD.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Philippine Nuclear Research Institute, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

Prospective bidders whose experience is at least 10 years shall be allowed to participate in the bidding. They should be a Philippine Contractor Accreditation Board (PCAB) registered contractor with **License Classification on General Building with Specialization in Structural Steel Work at least Category C and Size Range of at least Small B for Building and Industrial Plant for government projects**. Moreover, prospective bidders/contractors whose offices are not based in Metro Manila should have completed projects similar to the project for bidding within Metro Manila to enable the Procuring Entity to verify the quality of workmanship during post qualification evaluation.

For this purpose, similar projects shall refer to General Building.
