The eligibility Check/Screening as well the Preliminary Examination of Bids shall use the non-discretionary "pass/fail" criteria.

All particulars relative to the Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post Qualification and Award of Contract shall be governed by the pertinent provisions of the Approved Implementing Rules and Regulations (IRR) of R.A. 12009.
