The Philippine Nuclear Research Institute (PNRI), through the Bids and Awards Committee (BAC), invites interested bidders to bid for hereunder project:

The bidding documents can be obtained from the BAC Secretariat after payment of non-refundable amount of ten thousand pesos (₱10,000.00) at the PNRI Cash Section, FAD.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Philippine Nuclear Research Institute, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

Prospective bidders whose experience is at least 10 years shall be allowed to participate in the bidding and must be a Philippine Contractor Accreditation Board (PCAB) registered contractor for government projects with License Category of at least C and Size Range at least Small B for Building and Industrial Plant with Specialty in Painting Works. Moreover, prospective bidders/contractors whose offices are not based in Metro Manila should have completed projects within Metro Manila similar to the project to bid, so that the Procuring Entity can verify the quality of workmanship during post qualification.

The eligibility Check/Screening as well the Preliminary Examination of Bids shall use the non-discretionary "pass/fail" criteria.

All particulars relative to the Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post Qualification and Award of Contract shall be governed by the pertinent provisions of the 2016 Revised Implementing Rules and Regulations (IRR) of R.A. 9184.
