To exhaust all legitimate avenues for negotiation and settlement regarding any claim for compensation against the Institute or any of its officials for any physical injury or loss of life including radiation sickness or injury, arising out of or during the course of the training/research work/work at the Institute from any cause whatsoever;
3. To be held jointly and severally liable for the loss, destruction or damage to any and all equipment, tools, instruments, devices and other materials, access to or use of which is made available to the trainee by virtue of or during the course of the training/research work/ work in the Institute, provided, that such loss, destruction, or damage is the proximate result of the trainee's negligence or willful act;
4. To ensure that the trainee submits, if required, to physical and medical examinations before starting, during and upon the termination of the training/research work/ work at the Institute;
5. To ensure that the ward obtains a property clearance from the Institute upon completion and termination of my training/research work/work at the Institute.
6. That in case the trainee reaches the age of majority during the course of the training/research work/work at the Institute, to ensure that the trainee duly assumes these responsibilities/obligations I assumed on his/her behalf, to be facilitated by the Institute.
