- e) The PNRI scientist/researcher supervising the thesis student shall be the major adviser for researches under the program;
- f) All research results, including any inventions or discoveries arising therefrom, shall become property of the PNRI. The thesis student is included among the authors for any PNRI publications resulting from the study. The thesis student may initiate publication of the results of the study, subject to existing laws and regulations and, in the interest of national security, only upon the expressed permission of the PNRI, provided that the thesis report and any publications arising from it shall acknowledge the contribution of PNRI:
