WITNESSETH

WHEREAS, the PNRI is charged, among other things, with the responsibility of promoting and advancing
the peaceful uses of nuclear energy as well as the development of nuclear manpower of the country;

WHEREAS, among the avenues open to the PNRI in the realization of the above objective is through
linkages with universities and institutions of learning to promote training programs and researches along the fields of
expertise of PNRI;

WHEREAS, the _____ is desirous to send thesis students, namely,
_____ to the PNRI
to avail of the facilities and services of PNRI, or avail of thesis/ research advisorship from PNRI personnel for their
thesis/ research entitled _____.

NOW THEREFORE, in consideration of the above premises, and their mutual covenants herein after set
forth, the Parties hereto agree, as they have agreed on the following:

1. That PNRI shall accept thesis students from _____
under the established PNRI Thesis/Research Advisorship Program hereinafter referred to as PROGRAM subject
to the following terms and conditions:
 - a) The thesis student should satisfy the PNRI requirements to the Program as follows:
 - i. letter of recommendation by the school thesis adviser,
 - ii. endorsement of the recommendation to the PNRI by an authorized school official,
 - iii. medical certificate by a certified physician attesting the fitness of the student to undertake the work,
 - iv. duly accomplished application form and Confidentiality Agreement submitted to Nuclear Training
Center of PNRI by the student;
 - b) The accepted thesis student shall be entitled only to the following:
 - i. under supervision, the use of available PNRI equipment, instruments and research facilities needed in
the conduct of research;
 - ii. use of PNRI library facilities;
 - iii. free film badge service; and
 - iv. under supervision, use of materials and supplies readily available at the PNRI;

- c) The accepted thesis student shall not be considered a PNRI employee and shall not be entitled to any remuneration or other privileges except as stipulated herein;
- d) Thesis research outside the scope of the PROGRAM, but duly authorized by the PNRI Director, shall be considered a technical service and the student shall be charged fees in accordance with PNRI Administrative Order Number 02, Series of 2004;
- e) The PNRI scientist/researcher supervising the thesis student shall be the major adviser for researches under the program;
- f) All research results, including any inventions or discoveries arising therefrom, shall become property of the PNRI. The thesis student is included among the authors for any PNRI publications resulting from the study. The thesis student may initiate publication of the results of the study, subject to existing laws and regulations and, in the interest of national security, only upon the expressed permission of the PNRI, provided that the thesis report and any publications arising from it shall acknowledge the contribution of PNRI;
- g) The PNRI library shall be furnished a copy of the thesis;
- h) The PNRI shall have the right to determine priorities if a conflict arises between the conduct of the thesis research and the other research projects of the PNRI;
- i) The PROGRAM shall not include the use of PNRI facilities and/or personnel for thesis report preparation work such as typing, illustration work, reproduction, binding, etc.

2. This Memorandum of Agreement takes effect _____ until the thesis work is completed.
