KNOW ALL MEN BY THESE PRESENT:

This CONTRACT made and entered into by and between:

The PHILIPPINE NUCLEAR RESEARCH INSTITUTE (PNRI), Department of Science and Technology (DOST), a government agency existing under the laws of the Philippines, with principal office address at Commonwealth Avenue, Diliman, Quezon City, Philippines, duly represented by, DR. ALUMANDA M. DELA ROSA, Director, and hereinafter referred to as "PNRI".

- and -

NTPI INTERNATIONAL, INC. with principal office at Unit 719, Globe Telecom Plaza 2, Pioneer cor. Madison St., Mandaluyong City, Philippines, represented in this agreement by its President/General Manager, Mr. MARCELO C. ZAFRA and hereinafter referred to as "CONTRACTOR".

- WITNESSETH -

WHEREAS, the PNRI is desirous that certain work should be performed namely:

FABRICATION AND INSTALLATION OF CONVEYOR/PRODUCT HANDLING SYSTEM AND BEAM CATCHER

and has accepted the bid of the CONTRACTOR for such work in the amount of *THREE MILLION FOUR HUNDRED FIFTY THOUSAND PESOS AND (Php3,450,000.00).*

The whole project comprised in this contract shall be completed within **Sixty (60)** government working days in accordance with the approved proposal.

NOW, THEREFORE, the Parties hereto have agreed as follows:

- In this Contract, words and expressions shall have the same meaning as are respectively assigned to them in the conditions of the Contract hereinafter referred to.
- The following documents shall be deemed to form and be interpreted and construed as part of this Contract, viz:
 - a. Plans/Drawings
 - b. General Conditions and Technical Specifications
 - c. License/s
 - Bidding Documents

- f. Approved Budget for the Contract to be Bid
- Resolution of the BAC and/or BAC Recommendation for Award
- h. Invitation to Bid
- i. Bids and Abstract of Bids
- j. Performance Security
- k. Approved Notice of Award
- Approved Notice to Proceed
- m. Pertinent provisions of RA 9184, as amended 8 October 2003, its Implementing Rules and Regulations, and other applicable laws and rules.
- The CONTRACTOR binds himself to follow and execute faithfully the contract work and material specifications to be installed as listed in the Scope of Work which shall form part of this Contract.
- The PNRI shall furnish all information needed by the CONTRACTOR necessary in the execution of the contracted project.
- 5. The **CONTRACTOR** agrees and binds himself to comply with the standard workmanship of the contracted project. Non-compliance work on the part of the contractor, as maybe observed by the **PNRI's** Inspector/Representative, shall be immediately reworked/repaired at the expense of the **CONTRACTOR**.
- 6. The workers engaged by the **CONTRACTOR** to undertake the contracted project shall be considered as employees of the same. **SUB-CONTRACTING FOR THIS PROJECT IS STRICTLY PROHIBITED.**
- 7. The **CONTRACTOR** warrants that all laws and regulations appertaining to labor including SSS, Philhealth and ECC benefits, minimum wage, employer's liability in the employment of minors and the like, shall be complied with and shall hold the **PNRI** free from any claim of the **CONTRACTOR's** personnel.
- 8. Delivery of the contracted project shall be made by the **CONTRACTOR** in accordance with the terms specified in Section VI (Schedule of Requirements) and Section VII (Equipment Requirements and Technical Specifications) of the Bid submitted by the **CONTRACTOR**.
- 9. For the given scope of work of this **CONTRACT**, all bid prices are considered fixed prices, and therefore not subject to price escalation during the **CONTRACT** implementation, except extraordinary circumstances and upon prior approval of the GPPB in accordance with Section 61 of R.A. 9184 and its IRR-A..
- 10. The **CONTRACTOR** shall be liable for any damages as are warranted, when he abandons the project or wilfully/negligently causes damage/injury to the project personnel or damages to the facility of the **PNRI**; it shall be repaired/reworked at the expense of the **CONTRACTOR**.

- 11. For and in consideration of the aforementioned project to be rendered by the CONTRACTOR to the PNRI, the PNRI shall pay the CONTRACTOR the contract amount payable upon submission of accomplishment billing and all of the requirements specified in item no. 17.3, 17.4 and 17.5, Section V (Special Conditions of the Contract) of the Bid Documents herein published for public bidding, subject to final acceptance of the PNRI and the End-User, and submission of a SURETY BOND/WARRANTY specified in this contract and other required documents.
- 12. The CONTRACTOR shall post a Performance Security in favor of the PNRI in the form of Cash/Manager's Check equivalent to five percent (5%) of the total contract price or Surety Bond callable on demand, issued by a surety company duly certified by the Philippine Insurance Commission, equivalent to thirty percent (30%) of the total contract price, to guarantee the faithful performance of the CONTRACTOR under the contract. It shall guarantee payment of the amount of that security as penalty in the event it is established that the CONTRACTOR is in default in his obligation.
- 13. The CONTRACTOR agrees and binds himself to warranty all their works from any damage or defects due to faulty workmanship, for a period of one (1) year to start from date of acceptance of work. For this purpose, the CONTRACTOR shall furnish the PNRI with a Warranty Security, in the form of Cash Deposit/Cash Bond equivalent to five percent (5%) of the total contract price which shall be released after the warranty period or a Surety Bond with a duration stated above, callable on demand issued by the GSIS or a surety company duly certified by the Philippine Insurance Commission, equivalent to thirty percent (30%) of the total contract price, in accordance with paragraph 62.2.3.3, Section 62 of the Revised IRR of R.A. 9184, reckoned from the date of acceptance of the work by the PNRI, to answer for any loss, damage, injury or expense which may be incurred as a result of the defect in the CONTRACTOR's work.
- 14. The **CONTRACTOR** shall provide free training on operation procedures for the enduser, upon completion of the project.
- 15. In the event that the **CONTRACTOR** refuses or fails to satisfactorily complete the work within the specified contract time, plus any time extension duly granted, and is hereby in default under the contract, the **CONTRACTOR** shall pay the **PNRI** for Liquidated Damages, in an amount specified in paragraph 18.3 Section V of the Bid Document.
- 16. The **CONTRACTOR** shall clean and clear the whole premises of all waste and unused materials as a condition for completing the work and before acceptance of work by the end-user/Institute.
- 17. For any violation of the stipulation and covenants of this Contract, the **PNRI** reserves the right to terminate this **Contract** in the event of any breach of the stipulation hereof by notarial cancellation.
- 18. The **CONTRACTOR** warrants that it has not given or promised to give any money or gift to any employee or official of the **PNRI** to secure this **Contract**.
- 19. In case of dispute, the Parties hereunto agree that any and all actions arising from this Contract shall be filed in Quezon City only or shall be resolved in accordance with Republic Act 9285 ("R.A. 9285") otherwise known as the "Alternative Dispute Resolution Act of 2004...
