Dear Ma'am,

We received a message from AO25 last 16 February 2017 that PNRI is included in the Non-Compliant list for the Good Governance Requirements for the FY 2016 PBB. Verification showed that PNRI lacks Philgeps Certificate of Compliance for two (2) transactions.

Please be informed that upon receipt of AO25's reminder regarding submission of missing requirement last 12 January 2017, the BAC Secretariat immediately coordinated with Mr. Alvin M. LLapitan, Procurement Management Officer III of Philgeps. He advised the BAC Secretariat to provide justification on the remarks in the Certificate of Compliance, which the PNRI BAC Secretariat did. The Certificate of Compliance with justification was posted in the PNRI Transparency Seal on 30 January 2017 (copy attached). Unfortunately, it seems that Philgeps was not able to update AO25 on this matter.

Also, PNRI is not aware that justification form for non-compliant should be prepared and submitted to AO25. Copy of the justification form is accomplished and attached for your reference.

Hence, we would like to seek for reconsideration of PNRI compliant with the requirements.

We hope for your favorable action on this request.

Llapitan, Procurement Management Officer III. Mr. Llapitan told us to provide the reason in the remarks column. The BAC Secretariat revised the PhilGEPS Certificate of Compliance and put on the remarks the reasons for noncompliance. Consequently, the revised Certificate of Compliance was posted in the PNRI Transparency Seal on January 30, 2017.
